## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

### **As assinaturas digitais dispensam reconhecimento em cartório**

From time to time, Vli Multimodal S.A. (SAP) (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through your DocuSign, Inc. (DocuSign) Express user account. ### **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. ### **Withdrawing your consent**
